Tapped as Judges for Biennial Fresh Wood Student Competition

CITY OF COMMERCE – Jan. 12, 2011 -- Ten distinguished woodworking and furniture industry executives have been selected as judges for the AWFS 2011 Fresh Wood student woodworking competition.

Panelists include:

Fresh Wood judges begin their work in May, with a round of preliminary judging, then come together at the AWFS®Fair in Las Vegas, July 20-23, 2011 to select the winners.

Fresh Wood is a student woodworking competition open to full-time students in an accredited high school or post-secondary woodworking or related program and parttime students in an accredited post-secondary woodworking or related program who are transitioning into a career in woodworking or design within North America. The competition has six categories at both school levels: case goods, chairs, open, production/contract, reproduction and tables.
