Teachers

1. Your school's Tax Exempt Number **AND**
2. Your business card or a copy of your current staff identification **OR**
A letter from the school on school letterhead

Students

1. Current school identification card **PLUS**
2. Official letter (on school letterhead) from teacher/school verifying wood-related coursework **OR**
A copy of your current class schedule verifying wood-related coursework **OR**
Registered teacher is with student at time of registration on-site
